



Spectator Guidelines "Snapshot"

- i. If you are sick or display symptoms of COVID-19, **STAY HOME**
- ii. Ticket availability is limited. Fans are encouraged to purchase tickets in advance. Tickets may be available at the gate if seats are still available. All seating is General Admission.
- iii. Onsite Ticket sales will open at 2pm each day. Grandstand Gates and Suite Level will open at 5pm each day.
- iv. ALL Attendees can pay using cash or Credit/Debit card at Concessions and Merchandise trailers.
- v. Fans can enter the facility at 5pm each day. There will be NO early entry. You must stay in Grandstand area at ALL times and there will be no access to the Pit Area. Fans are permitted to leave and re-enter the facility with proper credentials.
- vi. ALL Attendees are encouraged leave one (1) parking spot in between each vehicle.
- vii. Upon arrival to the Facility you should be prepared for a COVID-19 Screening up to and including a Temperature Test. Anyone showing symptoms of COVID-19 or having a temperature over 100.3 degrees will be asked to leave the facility and see a physician.
- viii. Overnight camping is available at Knoxville Raceway for \$25/night and includes water and electric. This will be available at the gate.
- ix. The seating is General Admission for this event and WILL follow the CDC and local Public Health Department guidelines for social-distancing up to and including 6' separation between all groups and seating every other row in ALL grandstands. ALL Fans MUST keep 6' separation from the group next to them on both sides at ALL times.
- x. It is recommended, but not required, all Spectators wear a cloth face cover at all times, but we strongly recommend this when outside of your group.
- xi. ALL Attendees **MUST follow CDC Guidelines** throughout the entire event from entry onto the facility until exit. See below for ALL Guidelines up to and including Social-Distancing (6' separation), NO groups larger than ten (10).
- xii. Concessions will be available in the main grandstand. Fans should follow social-distancing guidelines while in line for tickets, merchandise or concessions.
- xiii. ALL Attendees must exit the facility no later than 1-hour following the Feature Checkered Flag unless camping overnight onsite.

Exhibit C – Spectator Guidelines

In preparing for the #ReturntoRacing you will read about **[CLEAN-COVER-CONFINE]**. As the country, and motorsports in particular, gradually eases back into business it is important to remember that everyone needs to remain aware of reducing and eventually eliminating the spread of COVID-19. Keeping these three simple words in mind as you go about your business will enable all of us to work toward the time when tracks will reverberate to the sound of race cars and will be full of cheering race fans.

1. PRE-EVENT

a. HEALTH

- i. If Attendee is sick or displays symptoms of COVID-19, STAY HOME
 - a. Covid-19 Symptoms includes Fever, Muscle Pain, Cough, Headache,
 Shortness of breath or difficulty breathing, Sore Throat, Loss of Taste or
 Smell, Chills or Repeated Shaking with Chills

b. PERSONAL HYGEINE

- i. Attendee should wash hands with soap and water every 20-minutes throughout the day...Sanitizer should ONLY support hand-washing, not take the place of.
 [CLEAN]
- ii. Attendee should avoid touching their face. [CLEAN-COVER]

c. PREPARATION

- ALL Attendees should be prepared with cash and debit/credit card for onsite payment. Ticketing, Concession and Merchandise will accept cash and Credit/Debit Cards. There will be an ATM onsite.
- ii. Attendees are recommended to bring a cloth Face Cover (or similar). PLEASE DO NOT use any medical-style Face Masks or Gloves that would otherwise be used by a health care worker. [COVER]
- iii. Concession Stands will be open in the Grandstand area with a limited menu.

d. CONSIDERATIONS

- i. If you live with someone over the age of 65 or with underlying medical conditions, you should consider staying home or be prepared to self-quarantine upon your return if you become sick or show COVID-19 Symptoms. **[CONFINE]**

e. TRAVEL

- i. Attendee should travel and attend with household contacts if possible.[CONFINE]

2. EVENT EXPERIENCE

a. KEY TIMES

i. 5pm: Gates Open

ii. 8pm: Racing

iii. 1-hour after Checkered Flag: ALL Exit (unless camping overnight onsite)

b. ARRIVAL

- i. Spectators will not be allowed to enter the facility before 5pm.
- ii. Spectators are recommended to leave at least one (1) parking space in between ALL vehicles. **[CONFINE]**

iii. Upon arrival to the facility you should be prepared for a COVID-19 Screening up to and including a Temperature Test.

a. Temperature scanners will be used to test all Attendees entering the Facility. Any Attendee with a temperature of 100.4 degrees or higher will not be allowed into the Facility.

c. TRANSACTIONS

Cash and Credit/Debit Cards will be accepted at Concessions...ALL
 Merchandise transactions are recommended by Credit or Debit Card, but
 cash will be accepted.

d. **MERCHANDISE**

 i. World of Outlaws Official merchandise and Platinum team members merchandise will be available in the Fan Midway.

e. **SOCIAL DISTANCING**

- i. Attendees should practice Social-Distancing at ALL times. When lining up to enter the Facility, buy Merchandise or for Concessions, Attendees should observe the pre-marked lines indicating six-feet spacing. [CONFINE]

f. GROUPS

 i. Attendees should NOT congregate in groups larger than ten (10), or as stipulated by local regulations and guidelines, and when/if doing so they should practice Social-Distancing and are recommended to wear cloth face covers. [COVER-CONFINE]

g. PERSONAL HYGEINE

- i. There will be hand-sanitizing stations located throughout the Facility. Attendees should wash hands with soap and water every 20-minutes throughout the day...Sanitizer should ONLY support hand washing, not take the place of. [CLEAN]
- ii. It is recommended, but not required, that Spectators should wear cloth Face Cover (or similar). PLEASE DO NOT use any medical-style Face Masks or Gloves that would otherwise be used by a health care worker. [COVER]

- iii. Attendee should avoid touching their face. [CLEAN-COVER]
- iv. Attendee should cover ALL coughs & sneezing. [COVER]

h. ACCESSIBLE AREAS

- i. ALL Spectators MUST stay in the Grandstand Area. [CONFINE]
- ii. There will be NO Spectator access in the Pit Area. **[CONFINE]**

i. **SEATING**

- i. Seats, cushions, and blankets are permitted inside the Facility.
- ii. ALL Attendees should maintain Social-Distancing (6' separation) between groups, no groups larger than ten (10) and MUST sit in every other row.[CONFINE]

j. CONCESSIONS

- i. A Concession Stand will be open with a limited menu will be open in the Grandstand area.
- ii. Food and beverages should be consumed at seat in grandstand. (There will be no "Food Court" or seating area for groups) [CONFINE]

3. POST-EVENT PLAN

a. EXIT

i. ALL Attendees MUST EXIT 1-hour after the Feature Checkered Flag.

b. HEALTH

- i. If an attendee feels any COVID-19 Symptoms within 72 hours of the event we ask you to contact the event organizer and see your primary doctor. **(CONFINE)**
 - a. Covid-19 Symptoms includes Fever, Muscle Pain, Cough, Headache,
 Shortness of breath or difficulty breathing, Sore Throat, Loss of Taste or
 Smell, Chills or Repeated Shaking with Chills
