



Spectator Guidelines “Snapshot”

- i. If you are sick or display symptoms of COVID-19, STAY HOME
- ii. Tickets are ONLY available prior to the event. All tickets will be picked up at Will Call as the patron enters the facility. Tickets will not be handed out in advance of the set time. There will be NO tickets available for sale at the Gate.
- iii. ALL Attendees should be prepared to pay CASH ONLY at concession stands and Credit Card/Debit Card at Merchandise trailers. There will be an ATM onsite.
- iv. Fans MUST enter the facility between the times of 3pm and 7pm. Anyone arriving before or after this time frame will NOT be permitted to enter the facility in accordance with CDC and COVID-19 screening guidelines. You must stay in Grandstand area once you enter the facility and there will be NO Re-Entry once you leave facility.
- v. ALL Attendees are encouraged to leave one (1) parking spot in between each vehicle. Tailgating is NOT permitted on the Facility Grounds.
- vi. Upon arrival to the Facility you should be prepared for a COVID-19 Screening up to and including a Temperature Test & Questionnaire. Anyone showing symptoms of COVID-19 or having a temperature over 100.3 degrees will be asked to leave the facility.
- vii. There will be NO onsite overnight Camping available. Camping available at the following: Missouri State Parks <https://mostateparks.com/campgrounds/lake-ozarks-state-park> or Missouri Assoc. of RV Parks/Campgrounds <https://campinmissouri.com>
- viii. The seating at this event WILL follow the CDC and local Public Health Department guidelines for social-distancing up to and including 6’ separation between all groups and seating every other row in ALL grandstands. Seat Cushions and Blankets are welcomed.
- ix. ALL Attendees are recommended to wear a cloth face cover. This is NOT mandatory.
- x. ALL Attendees **MUST follow CDC Guidelines** throughout the entire event. See below for ALL Guidelines up to and including Social-Distancing (*6’ separation*) and continued Personal Hygiene.
- xi. Concessions will be available in the main grandstand.
- xii. All Attendees MUST stay in Grandstand Area. There will be NO access to the Pit Area. ALL Attendees must exit the facility no later than 1-hour following the Feature Checkered Flag.

Exhibit C – *Spectator Guidelines*

In preparing for the return to racing you will read about **[CLEAN-COVER-CONFINE]**. As the country, and motorsports in particular, gradually eases back into business it is important to remember that everyone needs to remain aware of reducing and eventually eliminating the spread of COVID-19. Keeping these three simple words in mind as you go about your business will enable all of us to work toward the time when tracks will reverberate to the sound of race cars and the cheering of race fans.

1. PRE-EVENT

a. **HEALTH**

- i. If Attendee is sick or displays symptoms of COVID-19, STAY HOME
 - a. Covid-19 Symptoms includes Fever, Muscle Pain, Cough, Headache, Shortness of breath or difficulty breathing, Sore Throat, Loss of Taste or Smell, Chills or Repeated Shaking with Chills

b. **PERSONAL HYGEINE**

- i. Attendee should wash hands with soap and water every 20-minutes throughout the day...Sanitizer should ONLY support hand-washing, not take the place of.
[CLEAN]
- ii. Attendee should avoid touching their face. **[CLEAN-COVER]**

c. PREPARATION

- i. ALL Attendees should be prepared with cash and debit/credit card onsite. Concessions will be CASH ONLY and it is encouraged to use a card when purchasing merchandise. There will be an ATM onsite.
- ii. Attendee should bring cloth Face Cover (*or similar*)...PLEASE DO NOT use any medical-style Face Masks or Gloves that would otherwise be used by a health care worker. **[COVER]**
- iii. Two (2) Concession Stands will be open in the Grandstand area with a limited menu.

d. CONSIDERATIONS

- i. If you live with someone over the age of 65 or with underlying medical conditions, you should consider staying home or be prepared to self-quarantine upon your return if you become sick or show COVID-19 Symptoms. **[CONFINE]**

e. TRAVEL

- i. Attendee should travel and attend with household contacts if possible. **[CONFINE]**

2. EVENT EXPERIENCE

a. KEY TIMES

- i. 3pm: Gates Open
- ii. 7:30pm: Racing
- iii. 1-hour after Checkered Flag: ALL Exit

b. ARRIVAL

- i. Spectators will not be allowed to enter the facility before 4pm. Once in the facility there will be NO Re-entry if you leave.

- ii. Spectators are encouraged to leave at least one (1) parking space in between ALL vehicles. There will be NO Tailgating allowed in any Parking Area.

[CONFINE]

- iii. Upon arrival to the facility you should be prepared for a COVID-19 Screening up to and including a Temperature Test and Questionnaire.
 - a. Temperature scanners will be used to test all Attendees entering the Facility. Any Attendee with a temperature of 100.4 degrees or higher will not be allowed into the Facility.

c. TRANSACTIONS

- i. CASH ONLY transactions for Concessions...ALL Merchandise transactions are recommended by Credit or Debit Card.

d. MERCHANDISE

- i. World of Outlaws Official merchandise and Platinum team members merchandise will be available in the Fan Midway.

e. SOCIAL DISTANCING

- i. Attendees should practice Social-Distancing at ALL times. When lining up to enter the Facility, or for Tickets or for Concessions, Attendees should observe the pre-marked lines indicating six-foot spacing. **[CONFINE]**

f. GROUPS

- i. Attendees should NOT congregate in groups larger than ten (10), or as stipulated by local regulations and guidelines, and when/if doing so they should practice Social-Distancing and are encouraged to wear cloth face covers. **[COVER-CONFINE]**

g. PERSONAL HYGEINE

- i. There will be hand-washing stations located throughout the Facility. Attendees should wash hands with soap and water every 20-minutes throughout the day...Sanitizer should ONLY support hand washing, not take the place of. **[CLEAN]**

- ii. It is highly-recommended that Attendee should wear cloth Face Cover (*or similar*)... PLEASE DO NOT use any medical-style Face Masks or Gloves that would otherwise be used by a health care worker. **[COVER]**
- iii. Attendee should avoid touching their face. **[CLEAN-COVER]**
- iv. Attendee should cover ALL coughs & sneezing. **[COVER]**

- h. **ACCESSIBLE AREAS**
 - i. ALL Spectators MUST stay in the Grandstand Area. **[CONFINE]**
 - ii. There will be NO Spectator access in the Pit Area. **[CONFINE]**
- i. **SEATING**
 - i. Seats, cushions or blankets are permitted inside the Facility.
 - ii. ALL Attendees should maintain Social-Distancing (*6' separation*) between groups, no groups larger than ten (10) and MUST sit in every other row.
[CONFINE]
- j. **CONCESSIONS**
 - i. There will be two (2) Concession Stands open with a limited menu will be open in the Grandstand area.
 - ii. Food and beverages should be consumed at seat in grandstand. (*there will be no "Food Court" or seating area for groups*) **[CONFINE]**

3. POST-EVENT PLAN

- a. **EXIT**
 - i. ALL Attendees MUST EXIT 1-hour after the Feature Checkered Flag.
- b. **HEALTH**
 - i. If an attendee feels any COVID-19 Symptoms within 72 hours of the event we ask you to contact the event organizer and see your primary doctor. **(CONFINE)**
 - a. Covid-19 Symptoms includes Fever, Muscle Pain, Cough, Headache, Shortness of breath or difficulty breathing, Sore Throat, Loss of Taste or Smell, Chills or Repeated Shaking with Chills
